



## LINDSAY RACING PRODUCTS BRAND PRODUCT WARRANTY

As with most exciting and extreme sports, there are elements of danger and even violence to be found in racing – and it must be clearly stated that Lindsay Racing Products wheels have no structural or finish warranty expressed or implied other than those stated in the following document.

### **Defect Warranty:**

Lindsay Racing Products (LRP) warrants that all of its wheel components are free from defects in materials and workmanship for a period of 30 days from the original date of purchase. LRP's sole obligation under this warranty shall be to repair, replace, issue credit, or refund at LRP's sole discretion any LRP product which is returned (freight prepaid) and which, after LRP's examination, shows a defect in materials or workmanship. Discoloration, oxidation, and/or corrosion of the finish due to neglect, chemical reaction, or weather are not covered. This limited warranty applies only to the original purchase, and proof of purchase is required for warranty consideration.

### **Limits and Exclusions:**

1. This limited warranty provides the original purchaser with specific legal rights. The original purchaser may have other legal rights, which vary from state to state or country to country.
2. The transport company is solely responsible for any damage incurred during shipping, nor will this warranty apply to any such product. LRP shall be under no obligation to pursue restitution on behalf of the customer.
3. Lindsay Racing Products does not warrant any physically altered, improperly installed, improperly maintained or damaged product.
4. LRP hereby disclaims any implied warranty of merchantability or fitness for a particular purpose.
5. If there is, by law, an implied warranty of merchantability and/or fitness for a particular purpose, it is hereby limited to the warranty term set forth above and shall commence from the date of the original purchase.
6. LRP's obligation under this warranty is limited to the description on the face of this warranty, to the extent permitted by law.
7. It is the installer's responsibility to ensure that all of the wheels and/or components used on the race vehicle are correct before installation. The installer is responsible for determining the use or application of a wheel or component. Lindsay Racing Products hereby disclaims any liability for wheel and/or component selection and installation.
8. Wheels that have had tires mounted cannot be returned.
9. LRP is not responsible for incidental or consequential damages, property damage, personal damages, or exemplary damages, whether arising out of warranty, contract, tort or otherwise, incurred as a result of a defect in materials or workmanship.
10. LRP wheels are not tested or labeled to meet FMVSS 109 or ECE36 safety standards. It is expressly forbidden and illegal to sell these wheels for use on public streets or highways. To the extent permitted by law, any person selling or using LRP wheels for street use hereby agrees to indemnify, hold harmless, and reimburse LRP for all loss, damage, or liability incurred as a result of such use, including but not limited to attorney fees.

### **THE WARRANTY IS NULL AND VOID IF:**

1. The wheel is damaged in shipping, by misuse, accident or negligence, or has been repaired or altered by anyone other than Lindsay Racing Products.

2. The wheel is used in conjunction with a spacer or adapter of any kind. **WARNING:** An unapproved spacer or adapter may weaken the wheel and cause failure and/or the lug nuts may not have enough engagement length.
3. The wheel is used on applications beyond the wheel's specified load rating, or tires greater than the rated diameter are used, or if used in racing or competition.
4. The wheel is installed using incorrect fasteners or procedures, or where the finish has been damaged during tire mounting by the use of improper tools or by balancing with clip-on wheel weights.
5. Original invoice or sales receipt is not available for verification, or upon transfer of title on any products by the original retail purchaser.

**RETURN PROCEDURE:**

1. To ensure excellent customer service, LRP requires prior notice and approval before a customer returns merchandise for warranty or other reasons.
2. To obtain a Return Authorization (RA), the customer must contact Lindsay Racing Products at (623) 363-0551.
3. The RA# must be clearly marked on the outside of the package. Any returns arriving without this identification # will be refused. The wheel or part must be shipped with adequate protection to prevent damage – all products must be properly boxed and/or securely attached to a shipping pallet. In addition, the customer's name, address, phone number, fax, and/or other contact information, along with the explanation of the concern and/or work to be done must be included inside the package. This contact information is essential for LRP to communicate clearly and effectively with the customer.
4. All merchandise returned to LRP must be sent freight prepaid and insured, and delivered to:

5. LRP is not liable for any taxes or duties associated with international shipments.
6. Any item returned for credit must be in new and unused condition.
7. All returns will be inspected within 7 days of receipt of goods. The customer will be notified of the inspection report and credit authorization, if any, within 21 days of receipt of goods.
8. All warranty returns reviewed by LRP's Warranty Return Department and found not to be subject to warranty coverage will be returned to the sender, without repair or replacement and at the sender's expense, unless the sender has a prior arrangement to scrap all non-warrantable wheels.
9. Any product received in excess of the authorized return will be rejected and returned at the sender's expense.
10. LRP does not have a stock adjustment policy. No stock adjustment under the guise of a "product quality" claim will be accepted. LRP will scrap these products with no credit given.

**Important Highlights:**

1. All warranty returns reviewed by LRP's Warranty Return Department and found not to be subject to warranty coverage will be returned to the sender, without repair or replacement and at the sender's expense.
2. The issue of a Return Authorization (RA) is not an authorization for credit. **DO NOT** deduct the estimated credit from your payment. If warranty credit is approved, a written credit statement from LRP will be sent to you.
3. Unused non-warranty returns are subject to a 15% restocking fee, with no exceptions. Mounted wheels will not be accepted for returns.
4. The purchase price at the time of sale is final.
5. All shortage and error claims must be reported within 48 hours of receipt to be accepted for processing.
6. Any new product returned for credit will be rejected if received in other than as-new condition.
